Under the commodity levy order for onions, Onions New Zealand must set a levy rate by a vote at its annual general meeting.

MOTION 8

That BDO be appointed auditors for the financial year ended 30 June 2020.

Explanatory Note

BDO was awarded the contract to complete the audit for Onions New Zealand in 2016 in line with Horticulture New Zealand and other vegetable product groups.

MOTION 9

That the onions biosecurity levy be set at \$0/ha for years ended 30 November 2020.

Proposed by the Onions NZ Board

Explanatory Note

Onions New Zealand consulted with members on the establishment of a biosecurity levy for response activities and submitted the application for the introduction of this levy in December 2017. The Biosecurity (Response—Onions Levy) Order 2019 will be signed by the Governor General on 3 October, coming into force 1 November 2019. Year one of the Biosecurity levy will be 1 November – 30 November 2019. Year two will commence 1 December 2019 – 30 November 2020. It should be noted that under the terms of the Biosecurity Act the Board has the power to vary/strike a levy within the year should an incursion occur.
